

**NATIONAL REAL ESTATE CONVENTION
TRADE SHOW RULES & REGULATIONS FOR VENDORS**

This Vendor's Agreement is entered into by and between **Global Publishing, Inc.**, (hereinafter referred to as "PROMOTER") and _____ (hereinafter referred to as "Vendor").

In consideration of the promises and covenants contained herein, and intending to be legally bound hereby, the parties agree as follows:

1. **Event:** PROMOTER will sponsor and the Vendor agrees to participate and/or sell at the following event:

Vendors are not permitted to utilize any other order form and may not process sales. - 14. This Agreement shall be governed by the laws of the state of Florida and the venue for any litigation will be Duval County, Florida.
- 15. **Force Majeure:** Failure to perform any term or condition of this Agreement as a result of conditions such as, but not limited to acts of God, terrorism, disasters, or similar occurrences beyond the party's control shall not be deemed a breach of this Agreement.
